General Description of Program (Nature and Purpose, plus Desired Student Outcomes)

The setting is Arusha and Maasai area of Tanzania which is a developing country without adequate health care.

- Possible student responsibilities:
 - Engaging with community members, groups, national organizations/business to elicit needed resources and support for the field experience.
 - Participating with clinic activities, triaging patients, and providing medical/nursing care (as qualified by academic training) in remote villages.
 - Teaching basic health related programs specific to the villages such as the need to boil water, avoiding bathing in the rivers, prevention of mosquito infestations and basic hygiene techniques.
 - Working with a village on community development projects that involve building needed items for the village and families (digging latrines, pouring concrete floors, mudding walls).
 - Spending time in the community members' homes helps the students to develop a real understanding of the impact of environment on health.

- Witnessing a family sleeping on dirt floors and cooking fires that are indoors and without a smoke flue can all be directly related to the disease processes.
- Use their academic training to support specific community development projects, community initiatives, provide resources, educate, and form partnerships within communities.
- Global health related research involving developing communities, social interactions, etc. Assisting other NGO or world health-based organizations (WHO) conduct research or implement health related activities.

Desired student outcomes

- Discuss the context of health through society, culture, and developmental initiatives;
- Compare and contrast the use of conventional medicine with traditional medicinal practices;
- Examine the characteristics of developing societies and culture through a health focused lens;
- Discuss the impact of globalization on developing societies;
- Reflect upon the rich, multicultural historical contributions of the people on their social infrastructure.

NRSG 7410X: In these courses, students will be allotted 45 of 90 total clinical practice hours in the primary care clinical practicum hours.

NRSG 4980X: In this course, students will be allotted 36 clinical education/leadership hours and 36 clinical practicum hours of their total clinical hours of 240.

2) Course Delivery: Include content to be taught abroad, as well as pre- and/or post-program elements, including content to be taught on-campus or online.

In all four courses, students must meet national certification requirements as indicated in the professional programs (MSN and BSN). Students enrolled in these courses will be expected to complete assignments and requirements of the standard course (NRSG 7410 and NRSG 4980). Unlike students enrolled in the standard courses, students enrolled in NRSG 7410X and NRSG 4980X will have part of their precepted clinical experience in Tanzania.

Pre-program elements: All students complete orientation with IEC. Complete discussion of medical treatment of tropical diseases that may be encountered including Zika, Malaria, Dengue, Leishmaniasis, Chagas, Chikungunya and Bot Fly infestations. Graduate students are expected to recognize these disorders and know the protocols for treatment.

BSN students must meet all requirements to be enrolled in NRSG 4980X Clinical Internship (see catalog)

MSN students must meet all requirements to be enrolled in NRSG 7410X (see catalog)
No language requirements as interpreter are provided and most health workers speak English.

Study abroad program works in partnership with several medical facilities and NGOs to explore and observe public health care practices and challenges in Northern Tanzania.

Welcome and cultural orientation. Project introduction and planning.

Monday, April 6 Arusha

Head to Mt Meru, Ngarenaro and Levelosi Hospitals where students will be working with and observing local nurses and doctors as part of the Maternity Africa project. Maternity Africa works towards reducing maternal mortality and the incidence of obstetric fistula by improving skilled maternity care throughout Africa. Lectures on government healthcare in Tanzania. Overnight at Outpost Lodge and all meals are included.

Tuesday, April 7 Arusha

Visit the Faraja Center – medical workshop with the women in the program. Faraja is a registered NGO that provides vulnerable young women and girls below the age of 18 with temporary residence, education and vocational training. The women that are supported by Faraja are usually victims of human trafficking, forced child marriage, poverty, abuse and lack of educational opportunities. Faraja's goal is to train these women in order to empower them with employment and self-reliance. Vocational training at Faraja includes cooking tailoring, handcrafting and beauty workshops and women are also offered further education in mathematics computer skills, entrepreneurship and health care. Afternoon visit in Arusha Lutheran Medical Center with lecture from midwife Christy Miller. ALMC is a hospital situated in the heart of downtown Arusha and provides many special services including an Orthopedic institute, a laparoscopic surgery, a sexual abuse care center, and a neonatal intensive care until. Students will visit the hospital and learn about its achievements and challenges from a person on their medical staff

Medical workshop at Faraja Center with the resident women there. Afternoon visits to Maternity Africa.

Friday, April 10 Arusha/Tarangire

Spend the majority of the day game viewing in the park with a late transfer to Isoitok camp. Visit the African Roots Foundation (ARF) and learn about their community impact projects. Finish the day at the Isoitok Camp for a Sundown Walk. Our Maasai guide will take students for a walk through the bushland surrounding the campsite and head to Rift Valley Viewpoint. In Clinics seeing patients: Possibility of **blood and body fluid contact** and contact with tropical diseases and **mosquito borne diseases**

All individuals participating in the 2019 Tanzania medical team trip are superiorly trained in standard precautions and CDC recommendations for the prevention of transmission of tropical diseases, including Malaria. Students and faculty participating are Registered Nurses (or within months of becoming Registered Nurses), and all standard precautions will be utilized while in Honduras. Regular use of mosquito repellant is encouraged.

All students must have Hepatitis B vaccination prior to entry into the nursing program. All students must have the Hepatitis A vaccination prior to going to Honduras. Malaria prophylaxis is encouraged. Students carry water bottles complete with life straws for filtration of water. Edu Africa provides all food and additional safe water for drinking.

Qualifications are based on successful completion of pre-requisite courses and enrollment is open only for those students eligible to enroll in those courses. The number of FNP students per preceptor is set by the Georgia Board of Nursing at 6 students to 1 faculty member.

NRSG 4980X: Interested BSN students must have completed all pre-requisite courses and be eligible to enroll in the capstone course. Ten applicants will be chosen to go on this experience. Decisions will be based on the student's nursing program academic grades, recommendations from clinical faculty, experience abroad, Spanish speaking ability, and ratings on a formal essay.
