Computer Competency:

This is an online course. All classes will be conducted using either synchronous class format or asynchronous online class format. Students must have access to Internet and ability to use D2L and WebEx. Basic computer competency with Microsoft office is expected. Attendance and active participation is a course expectation.

Teaching/Learning Methods:

Lecture; PowerPoint presentations; required and recommended readings; and computer based exams to include unit and final examinations.

Topical Outline:

Foundations of pharmacology, Neurological medications, musculoskeletal medications, psychiatric medications, pain medications, anti-infective medications, cardiac/renal medications, pulmonary medications, endocrine medications, and GI medications.

Theory Evaluation:

Student's achievement of the course objectives will be determined by the successful completion of the required 3 unit exams and 1 comprehensive final exam.

If you are unable to be present for an exam, you must notify Dr. Sallie Coke <u>before</u> the exam is scheduled to begin. Failure to do so will result in a "0". **No makeup exams will be given**. The percentage of the missed exam will be added to the percentage of the final exam. Students will need to be able to document reason for missing an exam (doctors note, etc.).

Grade Computation:

There will be three (3) computer unit based exams and a final. Each exam is worth 25% of the total course grade. There will be a comprehensive final exam worth 25% of the total course grade.
